# Thurston Conservation District is looking for an experienced self-starter who is a dynamic, energetic, highly organized creative thinker with an interest in natural resources conservation and agricultural viability. The successful applicant must have a strong work ethic to become part of a cohesive team of passionate individuals in a fast-paced, hands-on and rewarding work environment.

# **POSITION DESCRIPTION:**

This position is responsible for working with farmers, landowners, and residents in Thurston County to assist with planning and development of conservation plans for their properties and operations. The Natural Resource Technician assists community members with identifying and implementing a wide range of natural resource conservation practices using State Natural Resource Conservation Service of Washington conservation assessment tools. This position will also provide technical assistance to community members to facilitate implementation of cost share projects. A primary focus will be small farm planning and technical education. Additional experience in water quality monitoring and stream habitat restoration is helpful. This position coordinates and implements other field projects as assigned by the Conservation Program Manager. This position may occasionally supervise other volunteers, interns, work crews, and/or project contractors on specific projects.

The Natural Resource Technician is responsible for aligning District and partner programs to benefit both the landowner/operator and the soil, water, air, plant, and animal natural resources present on the property. Knowledge of the local, state and federal regulations and permitting processes is desired. This position will work directly with a highly collaborative and professional technical team of four, under the mentorship of the Conservation Program Manager, to identify, develop and implement projects that address natural resources and habitat concerns. Thurston Conservation District offers a dynamic, fast-paced, and passionate work environment with a supportive staff team. We are governed by volunteer community stakeholders who generously donate their time to serve on our Board of Supervisors and bring additional knowledge, experience and unique perspectives to support and strengthen the mission of the District.

This position description represents a general outline of the job duties, essential functions and minimum qualifications and is not intended to be comprehensive in nature. Eligibility for this position is contingent upon the individual's ability to perform the essential functions with or without reasonable accommodation. This position requires frequent sitting, standing, walking over difficult terrain and on construction sites, lifting up to 50 lbs., occasional travel and periodic evening and weekend work.

## **PRINCIPAL RESPONSIBILITIES:**

• Builds relationships with and provides excellent customer service to a wide range of public and elected officials, technical and conservation experts, farmers, landowners, and community members.

- Identifies and guides implementation of appropriate conservation practices that meet the needs of landowners/operators and also address natural resource concerns.
- Applies for cost-share funds and facilitates project implementation.
- Monitors and documents implementation of best management practices (BMPs) at field activity locations.
- Prepares reports and documents activities, program progress, and accomplishments as directed.
- Conducts soil tests and makes recommendations to community members based on test results and their goals.
- Collaborates with Education and Outreach staff to present at meetings, workshops, tours and educational opportunities, as needed.
- Participates in regular training opportunities to maintain a high level of proficiency.
- Attends public meetings as a representative of the district.

The duties listed above are intended only as general illustrations of the various types of work that may be performed. Specific statements of duties not included does not exclude them from the position if the work is similar, related, or a logical assignment to the position. Job descriptions are subject to change by the District as the needs of the District and requirements of the job change.

# MINIMUM QUALIFICATIONS:

<u>Education</u>: 1) Bachelor's Degree (B. A. / B. S.) in natural/environmental science, agriculture, agronomy, environmental planning, or closely related technical/scientific/natural resources field –OR— 2) B.A. / B.S. from an accredited institution in combination with experience in natural resource management as described above. –OR— 3) An associate degree in natural resource management from an accredited institution in combination with 2 years direct experience in natural resource management as described above.

## AND

<u>Work Experience</u>: A minimum of 1 year of professional natural resource management experience is required in ecology, botany, wetland science, upland or aquatic habitat restoration, or related work. Work experience can come from a government, corporate or other post-secondary training environment –OR– a combination of education, training, and experience that demonstrates the ability to perform the duties of the position are welcome.

Experience in project management, managing multiple deadlines, and clear professional report writing are essential. Knowledge of local and regional agricultural and conservation issues is important, as is interest in supporting and working with an active and sustainable farming community in South Puget Sound. In addition, familiarity with conservation project implementation, regulatory requirements, permitting, and critical areas is required. Other qualifications include: the ability to respect, collaborate, and work with diverse populations and perspectives and experience facilitating discussions on contentious resource management issues with community members and other stakeholders. This position requires excellent verbal and written communication skills, including proficiency with the Microsoft Office suite. Proficiency in GIS desired. Applicant must possess a valid driver's license.

# ADDITIONAL PREFERRED QUALIFICATIONS:

- Conservation Planner Certification from NRCS
- Proven experience developing and completing conservation plans.
- Certified Crop Advisor (CCA)
- Knowledge of agricultural industry and/or farming experience.
- Familiarity with Washington's Growth Management Act, Shoreline Master Program and policies, and various local ordinances and policies.

- Knowledge of scientific and engineering principles relative to conservation planning applications both in the field and in the office.
- Particular interest in working with the equestrian community and small farm operations
- Interest in soil science, testing, and analysis

## SCHEDULE & WORKING CONDITIONS:

This position is permanent, overtime non-exempt, and full-time (40 hours per week) with flexible work hours. Local and out-of-town travel, occasional evening and weekend hours are possible. Currently, as a as part of TCD's response plan to COVID-19, work will primarily be performed at home with occasional work in the District's office, as well as in the field. At times, this position spends as much as 45% of work time in the field. Employees are provided with necessary TCD-owned equipment to perform their job responsibilities outside of the office.

## COMPENSATION AND BENEFITS:

The Thurston Conservation District observes twelve (12) paid holidays (including two personal holidays). Employees also accrue sick and vacation leave. The District offers medical, dental, vision and life insurance coverage for employees, with an option to cover 75% of spouse or dependent coverage. Additional voluntary supplemental insurance opportunities are also available. Participation in regular professional development opportunities are strongly encouraged and supported. Thurston CD employees participate in <u>Public Employees Retirement System (PERS)</u>. Staff also has access to an additional voluntary retirement savings programs within the State of Washington's Department of Retirement Systems – <u>Deferred Compensation Program (DCP)</u>.
