POSITION DESCRIPTION

Work with the Habitat Restoration Crew Lead to supervisor and mentor the Thurston Conservation District (TCD) Veteran Conservation Corps Interns and TCD Habitat Restoration Field Crew Interns as they develop skills in the environmental field and complete meaningful habitat restoration projects in Thurston County.

DUTIES & RESPONSIBILITIES

- Aids in the completion of restoration projects based on direction from project managers and crew lead
- · Assists with leading, mentoring, and training crew members in a variety of restoration activities
- When the need arises and multiple sites require different tasks, the assistant will manage the time and productivity of crew members
- Accurately interprets and carries out restoration plans and maps
- Works for long periods of time in inclement weather, rough terrain, steep slopes, and wilderness areas
- Monitors, assists, and reports to the Lead or TCD staff when there is changing field conditions, crew activities, and equipment
- Effectively implements all safety procedures
- Assists with the operation and maintenance of small power tools and hand tools, such as chainsaws, weedeaters, shovels, and axes
- Operates state owned/leased vehicles and equipment, including passenger vans, pickup trucks, ATVs, and
- mowing equipment
- Safely hitches, hauls, and backs up a trailer
- Lifts up to 50-lbs repetitively for extended periods of time
- Works regularly with chemicals like pesticides and fertilizers

MINIMUM QUALIFICATIONS

We're looking for someone with a positive, friendly, and professional attitude who is excited to work with and assist the Habitat Restoration Crew Lead to implement restoration projects that will support the work of District staff. A minimum of two years of habitat restoration field work OR associate degree in environmental science OR any equivalent combination of experience and training that provides the required knowledge, skills, and abilities is required. Qualifying experience can come from a combination of educational experiences, military experience, volunteer positions, lived experience, and paid positions. Applicants who feel they would thrive in this position are encouraged to apply.

The successful candidate must possess the following skills and experience:

- Leadership skills
- Experience implementing safety practices in the field with and without supervision
- Experience working on a crew to complete time-sensitive projects on private or public property
- Habitat restoration and vegetation management techniques
- First aid/ CPR certification or the willingness to get certified

- Experience operating heavy equipment (mini-excavator, tractor, etc.)
- Have, or be able to obtain, a valid state driver's license.
- Possession of a Pesticide Applicators License

SCHEDULE & WORKING CONDITIONS

This position is a permanent, full-time position (40 hours per week) with a Mon-Thurs 7am-5:30pm work schedule. Local and out-of-town travel and occasional evening and weekend hours are possible. This position works primarily in the field, in all weather conditions.
