

Community Garden Ambassador Intern

Spring Term (March 31 – June 13) & Summer Term (June 23 – Sep 5)
6-10 Hours a week
\$1,000 Stipend

Can accommodate academic internship or independent study requirements

Position open until filled

Garden ambassadors will spend up to two hours per week in each of the three Olympia tiny home village gardens (Franz-Anderson, Quince St., and Plum St.). The ambassador will support garden health through irrigation monitoring, weed and pest management, seasonal and succession planning, compost management and education, and planting/harvest assistance and education. Additionally, the ambassador will attend weekly community meetings to continue garden education, learn about issues, concerns, and needs. A weekly check-in with Community Agriculture Program Coordinator to facilitate THV garden support will be necessary. (6 hours/week)

Garden ambassadors will support other community gardens in Olympia as needed, including sharing information about monthly garden activities, assisting gardeners, and other duties. The garden ambassadors may attend monthly TCD staff meetings, planned TCD workshops and events, and bi-weekly Education and Outreach team meetings as desired and available to learn more about conservation work in the community. Summer garden ambassador may support TCD Education and Outreach at the Thurston County Fair. Garden ambassadors may also help identify communities in need of community garden and/or support that are not part of the existing community garden structure. (4 hours/week)

NECESSARY & HELPFUL EXPERIENCE

- Must be 18 years of age or older
- Passionate about local food and gardening; urban ag experience helpful
- Knowledge of or interest in farming, gardening, or natural resource conservation
- · Strong interest in working directly with members of the public
- Clear written and verbal communication skills
- Ability to work independently with minimal supervision
- Ability to ask questions and take direction, when unsure of how to proceed, in order to complete assigned tasks
- Ability to work with vulnerable populations under sometimes stressful circumstances; experience working with people experiencing homelessness valuable but not necessary
- Valid WA State Driver's License or ability to obtain one strongly preferred
