NACD Update

Thurston Conservation District Board Meeting/Work Session of October, 2025

This update is mostly excerpted from NACD CEO Jeremy Peters' October 6, 2025 NACD Update on Recent Congressional and Executive Actions.

Working with and assembling data from various federal agencies affected by the government shutdown, NACD shares what it has learned as of October 6, 2025. Keep in mind these things change. EXCERPTS ON SPECIFIC AGENCIES

USDA

Natural Resources Conservation Service (NRCS) Approximately 96% of NRCS employees are furloughed. Activities such as conservation planning, practice implementation, and program support—including EQIP, CSP, RCPP, and related Farm Bill conservation programs—are suspended.

Terminated Agreements Last week (week of September 29), NRCS terminated several **Regional Conservation Partnership Program (RCPP)** agreements funded through the Inflation Reduction Act (IRA). Terminations were prompted by the recent recission of associated financial assistance (FA) funds, which made it impossible for the impacted projects to continue. NACD also encourages districts to share any impacts these terminations may have had on participating landowners and producers, including sharing impact stories with their Congressional representatives.

Farm Service Agency (FSA) 67% of FSA staff are furloughed. Most operations—including loan processing, program payments (ARC/PLC, CRP, ELRP), and new program enrollments—are suspended.

Forest Service (USFS) The Forest Service continues only essential operations related to fire suppression, emergency response, and protection of federal assets.

NACD Update

Thurston Conservation District Board Meeting/Work Session of October, 2025

EPA furloughed approximately 89% of its workforce during the lapse in appropriations. Only essential operations—including emergency response, Superfund cleanup, and law enforcement—will continue.

Department of the Interior (DOI) - Approximately 82% of DOI's workforce is furloughed.

Fish and Wildlife Service (USFWS) 66% on furlough. Law enforcement, care of captive animals, and activities funded under existing agreements continue.

Bureau of Land Management (BLM) Approximately 26% of BLM staff are furloughed. Feefunded and energy-related permitting, inspections, fire response, and public safety operations continue.

- In the October 6 update there is information (page 4) on Grassroots Advocacy (what to say; How to remain nonpartisan; Key messages, and a Shutdown Impacts template (for email, text, letters, leaving a phoner message, etc.) so you can tell your story. NACD's request for grassroots advocacy is an opportunity for members to share impact stories related to the shutdown and how your conservation district is affected, including a template letter that can be adapted and shared with your Congressional leadership.

Anticipated Impactful Legislation

- 1. Allowing the acquisition of water rights for agricultural purposes under the Conservation Futures program.
 - Thurston County is exploring a change to Chapter 84.34 RCW that would allow the purchase of interests or rights for strategic conservation purposes that would allow for the acquisition of water rights to support farmland preservation.
 - Thurston CD brought this concept to the Southwest Area meeting on October 16th and it was met with a tremendous amount of interest and support from CDs and partners.
 - TCD will support WACD and WSCC to explore an informational session at the WACD Annual Meeting around Conservation Futures and how to maximize support for developing local farmland preservation programs.
 - An example of a successful farmland preservation program funded through Conservation Futures (Skagit County Farmland Legacy Program): https://www.skagitcounty.net/Departments/NRFarmLegacy
- 2. Allowing an opt in general ballot option for Conservation District elections.
 - Interest continues from King County legislators to include a general ballot option for Conservation District elections.
 - A bill is likely to be forthcoming that may include provisions such as:
 - Individual CDs ability to choose to be on the general ballot at their own expense.
 - All supervisors would be required to fill out F1 financial disclosure form annually.
 - Elected supervisor terms would become 4 years instead of 3, and elections would take place every other year.
 - Potentially more than 3 supervisor positions would be elected positions.
 - The bill is likely to drop before the WACD Annual Meeting and WACD will provide a full update.

proactively addresses nonpoint pollution through watershed evaluations. These evaluations involve visits to targeted areas during the wet season where we assess potential sites from public rights-of-way. In the month of September, we conducted a total of **1 watershed evaluations** as listed in the table above. During these evaluations a total of **3 new sites were identified** in southwestern Washington.

If a landowner is unwilling or unresponsive a Warning Letter may be issued final attempt to detail the violation and its potential consequences, available resources, and a timeline for compliance. In September 2025, our staff sent out a total of **1 TA letter and 1 Warning Letter** across southwestern Washington as depicted in the chart attached.




Explore Nonpoint Pollution Strategies

Our <u>Nonpoint Pollution Webpage</u> provides general information on nonpoint pollution, details about the types of pollutants we manage and our efforts to address them. It also covers our regulatory authority, ongoing statewide plans,

the processes we use to collaborate with local partners and landowners and more.

Seeking more information on Ecology's BMPs?

Check out our Voluntary Clean Water
Guidance for Agriculture, a guide to water
quality BMPs intended to support healthy
farms while helping producers meet clean
water standards. This guide complements
existing resources like the NRCS Field Office
Technical Guides and helps producers make
productive water quality decisions during
farm planning. Ecology uses this guidance for
grant funding, watershed cleanup, technical
assistance, and outreach, while supporting
other programs in recommending water
quality projects to landowners.



We are currently working on the remaining eight chapters that will be submitted to EPA alongside the Nonpoint Plan by December 31, 2025. These chapters will have their own formal comment period, anticipated for this fall. Ahead of this, we are posting draft materials for early preview as available on our <u>webpage</u>. Four chapters are currently available to preview.
